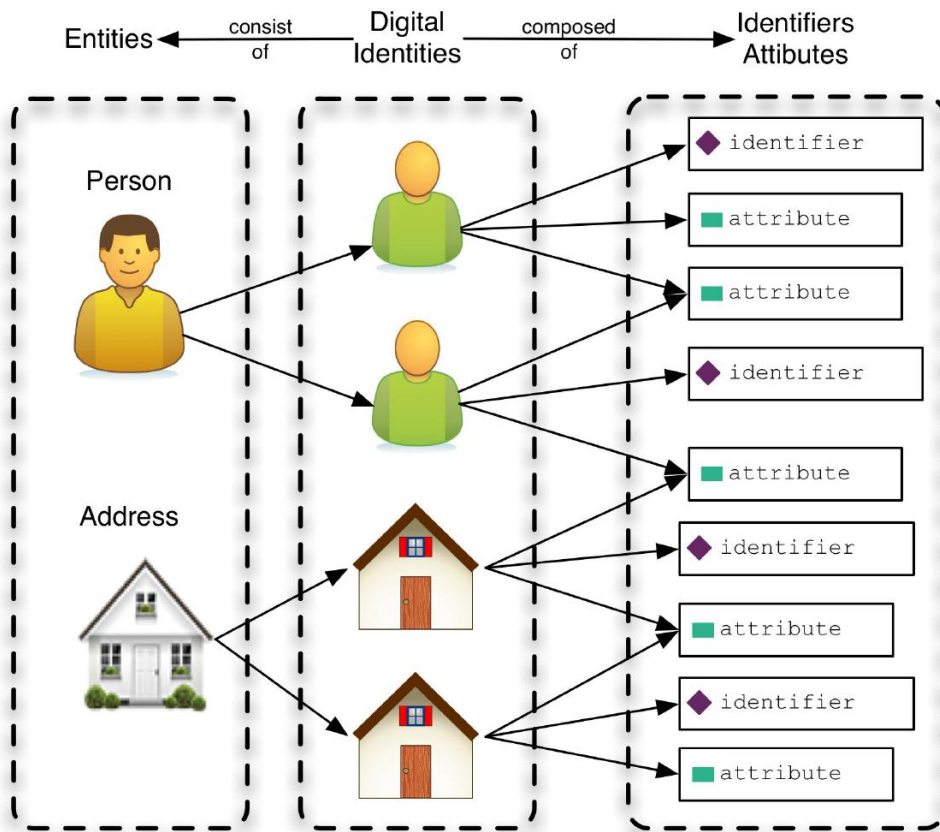

Managing Identities

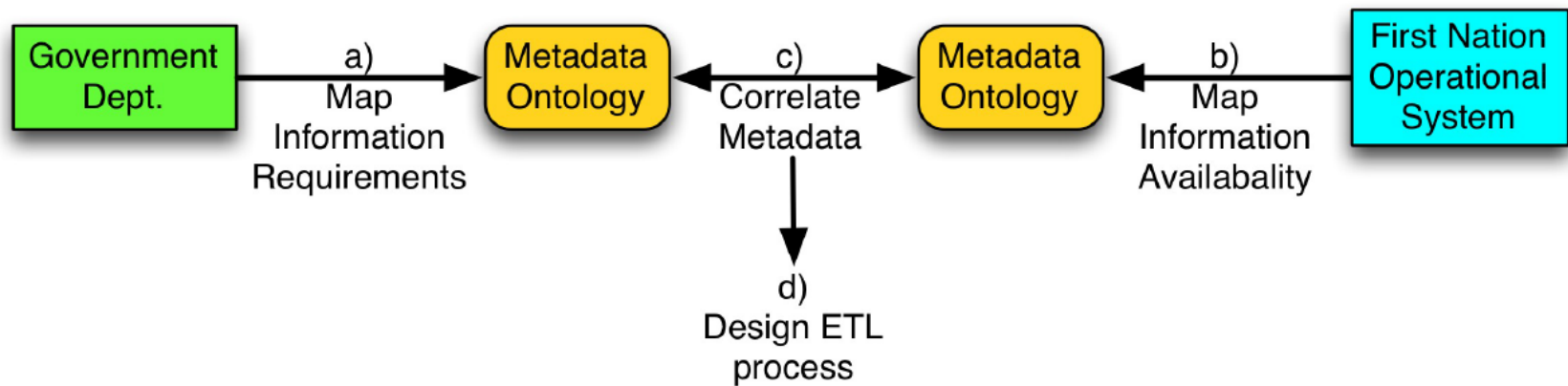


Citizen Identity Management is the process of ensuring that citizen information stored in different places can be matched to the proper citizen!

To acquire a complete picture for a person, the identity of other related entities, such as address, also need to be matched to the proper entity and person. This mapping is one of the responsibilities of Data Administration.

Extract Transform Load (ETL)

Extract Transform Load refers to a three step process that involves:

- Extract is the process of reading data from one or more sources.
- Transform is the process of converting the extracted data from its previous form into the form. This may involve applying a series of rules or conversion functions.
- Load is the process of writing the data to an end target.



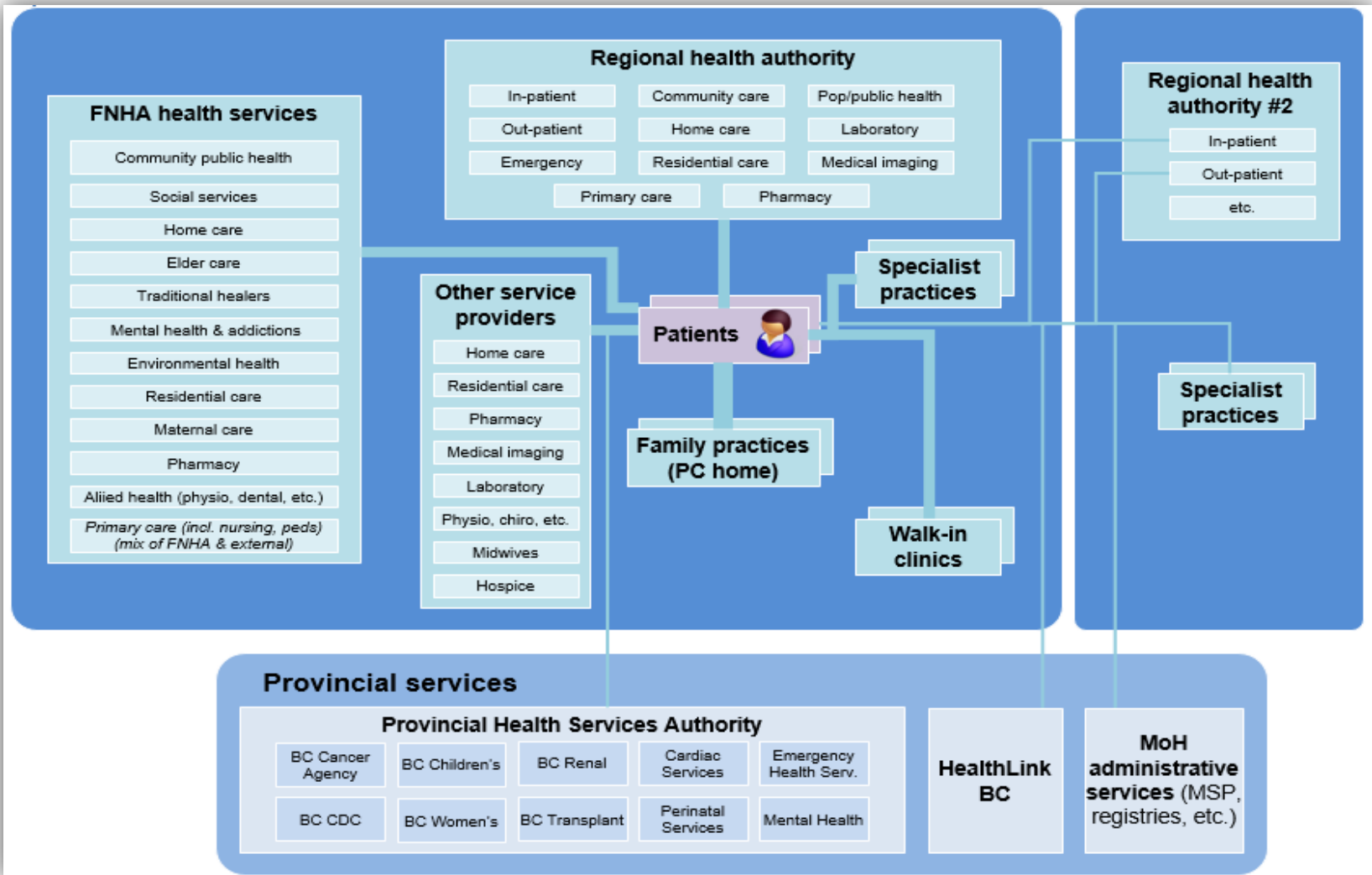
Why does the FNHA need to know you REALLY are you?

- FNHA is mandated to provide the following services:
 - Support our Research and Analytics requirements
 - Health Benefits Services

 - Supporting First Nations led research agenda, activities and research collaboration with its health and wellness partners (*internal and external to the FNHA*).
 - FNHA is mandated to improve the health and wellness of First Nations communities.
 - Improved community information
 - Enable First Nations to do health planning
 - Identifying strengths and gaps
 - How to best invest in health and wellness
- FNHA is also mandated to provide the following:
 - Access to accurate and most up to date client information at the point of care / service
 - Ability to be connected to the BC Health Systems



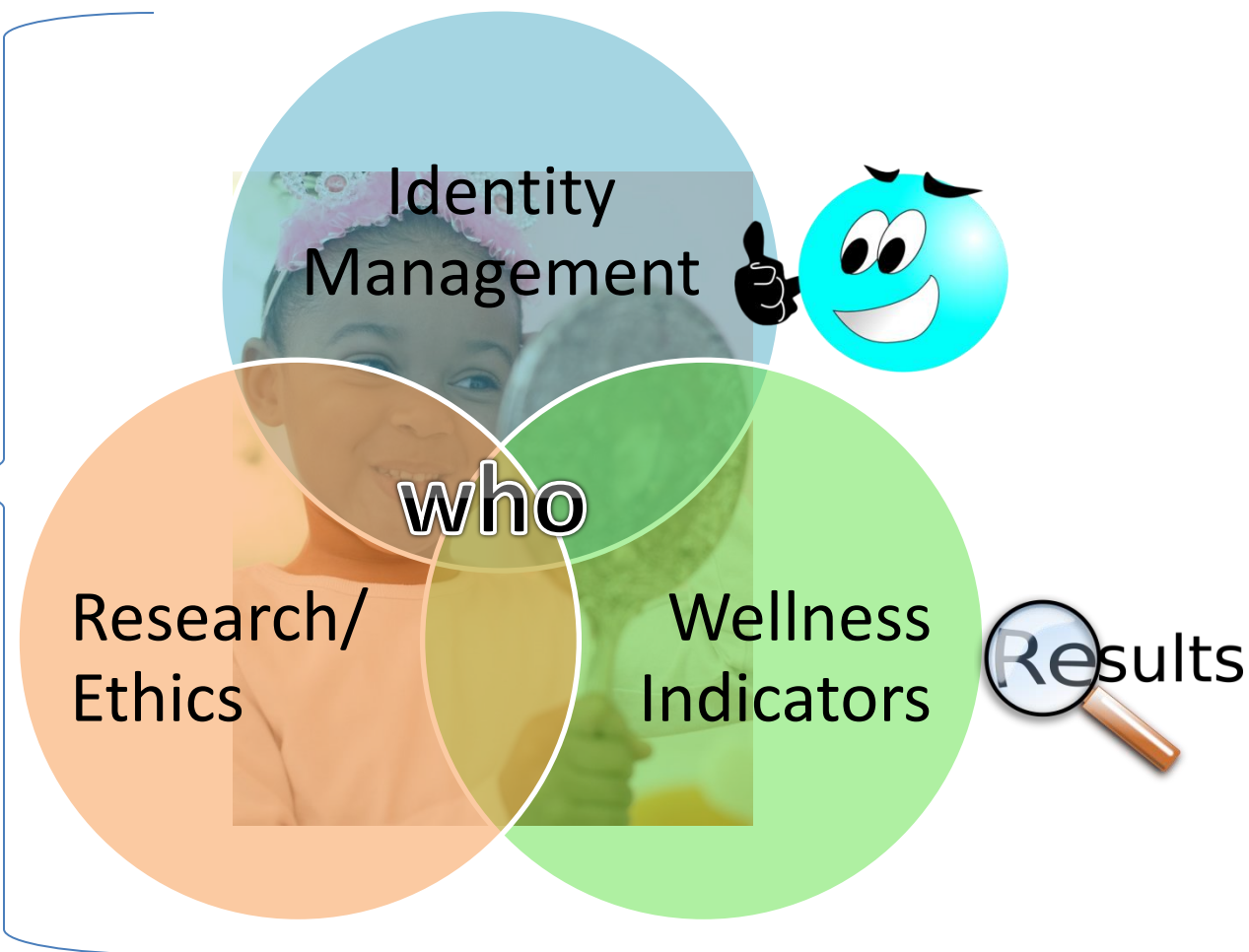
