#### Title: Nurse Practitioner

#### Background

Upper Nicola Band (UNB) is located 45 km east of Merritt and 90 km south of Kamloops, and has eight reserves located near Nicola Lake and Douglas Lake.

We are seeking to employ a Nurse Practitioner (NP) for two full days per week (0.4 fte) based in the Health Centre. This position will report to the UNB Health & Social Director.

The Nurse Practitioner (NP) will be working collaboratively with the Upper Nicola health care team (Community Health Nurse, Home Care Nurse and Family Therapist) and will work in liaison with GPs, Specialists, primary providers and the mental, dental and general nursing health providers. The NP will be the initial source of contact with GPs, collect appropriate data, identify the nature of health-related problems, psychosocial background and work in full scope treating and managing primary health care issues as appropriate.

The NP will provide full scope primary care including mental health and substance use including services to women, men, youth, infants and children (a large component of the role being chronic disease management and co-morbidities).

The role requires the NP to bring great clinical leadership, communication, problem solving, and conflict resolution skills, and to be an effective team member.

## Job Classification:

#### Job Purpose:

The Nurse Practitioner (NP) will be working collaboratively with the Upper Nicola health care team (Community Health Nurse, Home Care Nurse and Family Therapist) and will work in liaison with GPs, Specialists, primary providers and the mental, dental and general nursing health providers. The NP will be the initial source of contact with GPs, collect appropriate data, identify the nature of health-related problems, psychosocial background and work in full scope treating and managing primary health care issues as appropriate.

The NP will provide full scope primary care including mental health and substance use including services to women, men, youth, infants and children (a large component of the role being chronic disease management and co-morbidities).

The role requires the NP to bring great clinical leadership, communication, problem solving, and conflict resolution skills, and to be an effective team member.

- 1. The comprehensive assessment of community members' health including diagnosing diseases, disorders, and conditions within the NP scope of practice.
- 2. Initiating treatment including health care management, therapeutic interventions and prescribing medications in accordance with the statutory and regulatory standards, limits, and conditions, and UNB policies and procedures.
- 3. Providing ongoing monitoring of care, including the ordering of appropriate diagnostic screening investigations, interpreting and communicating results and prognosis, and making referrals to specialist physicians and others as appropriate.
- 4. Providing professional guidance to other health professionals and practices autonomously and interdependently within the context of an interdisciplinary health care team.
- 5. Helping support a population health focus by implementing screening and health promotion activities for those at risk.
- 6. Participating in interdisciplinary staff and nursing education through case presentations, mentoring, role modeling and facilitating the exchange of knowledge.
- 7. Comply with all applicable legislation and UNB policies and procedures.
- 8. Perform other appropriate duties as assigned by the Health & Social Director.
