JOB DESCRIPTION

The HCCN will combine health sciences, knowledge and experience in assessment, supervisory and clinical nursing skills to effectively coordinate and deliver client care to individuals and families needing acute, chronic, or palliative care approaches.

TYPICAL DUTIES AND RESPONSIBILITIES:

- Delivers direct nursing care as required.
- Using a structured process, in collaboration with the client and family, assesses, plans, delivers, evaluates, and documents an individualized client assessment which reflects the client goals and priorities. Provides consistent follow-up and changes plans of care as needed.
- Promotes and provides health related knowledge and treatment services to clients and caregivers, supporting independence and family and community values.
- Leads development of a client centered care plan, as appropriate within scope Document assessments, care plans, reassessments, and service delivery on clients' personal Home Care Health Record.
- Coordinate nursing care services with the client, physician, hospital, rehabilitation, long term care programs and other community services/programs. I.e. mental health, social development, nutrition programs, etc.
- Provides supervision, education, and support to care aides and homemakers on the home care team
- Maintenance of confidential reporting and recording data systems.
- Develop nursing care and teaching strategies to assist clients/families dealing with chronic illness. Participate and attend education in-service or provide other educational programs to health care staff as required.
- Collaborates with members of the interdisciplinary team to ensure effective, consistent, and comprehensive care planning and delivery.
- Evaluates the appropriateness, effectiveness and efficiency of the interventions of care designed to meet client needs and adapt as necessary in collaboration with the client and family.
- Support adult activities program initiatives and outings that promote independent living, traditional wellness, and continued socialization in and out of the community.
- Maintains a safe environment for clients/family unit and staff.
- Contributes to the development and revision of standards of care, policies and procedures; participate in the resolution of issues, and advocates for improvements in clinical nursing practice, health care, and services.
- Proficiency in the use of computers, internet applications, and required reporting.

Qualifications:

- Nursing degree (RN) or diploma (LPN) from a recognized Canadian University or College or recognized equivalent.
- Member in good standing and current practicing registration with the
- British Columbia College of Nursing Professionals (BCCNP). Knowledge of cultural safety principles and working within First Nations health and social development areas, understanding social determinants of health.
- Criminal record check
- Valid BC Driver's License
