The renewal of FNHA's Multi-Year Capital Plan provides an opportunity to confirm priorities and planning approaches for the next five years to further enable the delivery of community programs and services. We are currently in the final stages of completing the Multi-Year Capital Plan FNHA inherited from Health Canada, and are looking to gather input in Fall 2020 to shape our organization's path from April 2022 – 2027.

PURPOSE: Gather input from BC First Nations and leaders on capital priorities and approaches for the next five years.
